MCS Admission & Fee Schedule 2023/2024:

1. Group Tour (new families)
2. Submission of application
3. Family interview including both parents and student mandatory for all new incoming families and may be requested for returning families based upon any previous concerns (discipline warnings, excessive absences/tardies, frequent missing/late work, etc.).
4. Admission status will be determined and communicated to the applying family on the 1st of each month, beginning March 1st.

DEPOSITS:

Upon acceptance of your student's application (Family Information and Student Information forms or Student Intent to Re-enroll), families reserve a seat by paying the application fee of \$500/family. The application fee is **non-refundable. It also signifies your commitment to enroll your child(ren) for the 2023-2024 school year and pay for all tuition costs.**

TUITION:

Tuition for the 2023-2024 school year is as follows:

ECE/Pre-K: \$2,500

K-5th grades \$2,750

6th-8th grades \$3,150

9th-12th grades \$3,450.

For additional a la carte options for 10th-12th grades, see details below.

TUITION PAYMENT OPTIONS for ECE & Pre-K:

1. Pay in full \$2,500/ECE or Pre-K child, on or before June 30, 2023.

2. Pay two equal payments of \$1,400/ECE or Pre-K child, on or before June 30, 2023, and \$1,100/ECE or Pre-K child on or before November 2, 2023, totaling \$2,800.



3. Pay ten monthly payments of \$300/ECE or Pre-K child, totaling \$3,000. First payment is due by June 30, 2023. This option is ONLY available with credit card automatic withdrawal for 10 consecutive months. Regardless of when card information is entered, payments will start on June 30, 2023 and end April 1, 2024.

TUITION PAYMENT OPTIONS for Kindergarten-5th Grades:

1. Pay in full \$2,750/K-5th grade student, on or before June 30, 2023.
2. Pay two equal payments of \$1,525/K-5th grade student on or before June 30, 2023, and \$1,525/K-5th grade student on or before November 2, 2023, totaling \$2,800.
3. Pay ten monthly payments of \$325/K-5th grade student, totaling \$3,250. First payment is due by June 30, 2023. This option is ONLY available with credit card automatic withdrawal for 10 consecutive months. Regardless of when card information is entered, payments will start on June 30, 2023 and end April 1, 2024.

TUITION PAYMENT OPTIONS for 6th-8th Grades:

1. Pay in full \$3,150/6th-8th student, on or before June 30, 2023.
2. Pay two equal payments of \$1,725/6th-8th grade student on or before June 30, 2023, and \$1,725/6th-8th grade student on or before November 1, 2023, totaling \$3,450.
3. Pay ten monthly payments of \$365/6th-8th grade student. First payment is due by June 30, 2023. This option is ONLY available with credit card automatic withdrawal for 10 consecutive months. Regardless of when card information is entered, payments will start on June 30, 2023 and end April 1, 2024.

TUITION PAYMENT OPTIONS for 9th-12th Grades:

1. Pay in full \$3,450/9th-12th student, on or before June 30, 2023.
2. Pay two equal payments of \$1,875/9th-12th grade student on or before June 30, 2023, and \$1,875/9th-12th grade student on or before November 2, 2023, totaling \$3,750.
3. Pay ten monthly payments of \$395/9th-12th student, totaling \$3,950. First payment is due by June 30, 2023. This option is ONLY available with credit card automatic withdrawal for 10 consecutive months. Regardless of when card information is entered, payments will start on June 30, 2023 and end April 1, 2024.

ALA CARTE TUITION PAYMENT OPTIONS for 10th-12th Grades :

1. Pay in full \$1,300 per class: ELA/History (combined), on or before June 30, 2023.
2. Pay in full \$950 per class: Math, Science with lab, on or before June 30, 2023.
3. Pay in full \$750 per class: Electives, on or before June 30, 2023.

Full and half payments can be made in the form of cash, check (made payable to Magnolia Christian School) or by credit card.

There is a \$50/student late fee after June 30, 2023.

ESE TUITION PAYMENT OPTIONS for Kindergarten - 12th Grade:

- _____ 1. Pay in full \$2,000/ESE student, on or before July 1, 2023.
- _____ 2. Pay two equal payments of \$1,100 per ESE student, on or before July 1, 2023, and \$1,100/ESE student on or before November 1, 2023, totaling \$2,200.



Full and half payments can be made in the form of cash, check (made payable to Magnolia Christian School) or by credit card.

Tuition refunds are not given for any reason after June 30, 2023, and full payment is required regardless of attendance.

Statement of Faith:

Magnolia Christian School embraces the truths of the Nicene Creed:

We believe in one God, the Father Almighty, Maker of heaven and earth, and of all things visible and invisible.

And in one Lord Jesus Christ, the only-begotten Son of God, eternally-begotten of the Father; God of God, Light of Light, very God of very God; begotten, not made, being of one substance with the Father, by whom all things were made. Who, for us and for our salvation, came down from heaven, and was incarnate by the Holy Spirit of the virgin Mary, and was made man; and was crucified also for us under Pontius Pilate; He suffered and was buried; and the third day He rose again, according to the Scriptures; and ascended into heaven, and sits at the right hand of the Father; and He shall come again, with glory, to judge the living and the dead; whose kingdom shall have no end.

And we believe in the Holy Spirit, the Lord and Giver of Life; who proceeds from the Father and the Son; who with the Father and the Son is worshiped and glorified; who spoke by the prophets.

And we believe in one holy catholic and apostolic Church. We acknowledge one baptism for the remission of sins; and we look for the resurrection of the dead, and the life of the world to come. Amen.*

*Use of the word "catholic" in this context refers to the collective church around the world, NOT the Roman Catholic Church. We are a Protestant (non-denominational) organization.

Furthermore,



We believe the Scriptures, both Old and New Testaments, to be the inspired Word of God, without error in the original writings, the complete revelation of His will for the salvation of men, and the Divine and final authority for all Christian faith and life.

We believe in one God who is Creator and Ruler of the universe, infinitely perfect and eternally existing in three persons; the Father, the Son, and the Holy Spirit. These three are co-equal.

We believe that Jesus Christ is the Son of God. He is co-equal with the Father, and is fully God and fully man in one person. He was born of the Virgin Mary, and lived a sinless human life. He offered Himself as the perfect sacrifice for our sins by dying on the cross. Further, He arose bodily from the dead, demonstrating His power over sin and death. He ascended into Heaven, where, at the right hand of the Father, He now is our High Priest, and Intercessor. He will return again someday to earth to reign as King of Kings, and Lord of Lords.

We believe in the deity of the Holy Spirit; that He is equal with the Father and the Son as God. He convicts and regenerates the believing sinner, and indwells, baptizes, seals, guides, gifts, instructs, and empowers the believer for godly living and service.

We believe that humanity was created in the image of God, but by voluntary transgression fell into sin and is thereby separated from God.

We believe that the death of Jesus Christ and His resurrection provide the only ground for justification and reconciliation to God. We can never make up for our sin by self-improvement or good works. Only by trusting in Jesus Christ can man be saved from sin's penalty and receive God's gift of eternal life.

We believe that the church is composed of all true believers in Jesus Christ and are united together in the body of Christ of which He is the Head.

We believe that God created marriage to be the union of one biological male and one biological female in a single, exclusive union, as recorded in Scripture. We believe that God intends sexual intimacy to occur only between a man and a woman who are married to each other. We believe that God has commanded that no sexual activity be engaged in outside of a marriage between a man and a woman.
